**AN ORDER ORGANIZING THE GENDER AND DEVELOPMENT
(GAD) MONITORING AND EVALUATION (M & E) TEAM OF
LAOAG CITY**

WHEREAS, the 1987 Philippine Constitution declares that the State recognizes the role of women in nation-building, and shall ensure the fundamental equality before the law of women and men.

WHEREAS, Republic Act No. 9710, otherwise known as the "*Magna Carta of Women*" provides for policies and procedures in mainstreaming gender perspective in local planning, programming and budgeting; local legislation; project development, implementation, monitoring and evaluation;

WHEREAS, Philippine Commission on Women, Department of the Interior and Local Government, Department of Budget and Management, National Economic and Development Authority (PCW-DILG-DBM-NEDA) Joint Memorandum Circular (JMC) No. 2013-1, as amended by JMC 2016-01 entitled Guidelines on the Localization of Magna Carta of Women provides for the creation of the Gender and Development (GAD) Monitoring and Evaluation (M & E) Team;

WHEREAS, the creation of the GAD M & E Team of Laoag City would strengthen the M & E System for gender-responsive programs and projects;

WHEREAS, to evaluate the outcomes of the GAD programs, policies, projects and activities, there is a need to organize the GAD M & E Team of Laoag City;

NOW THEREFORE, I, MICHAEL MARCOS KEON, City Mayor of Laoag City, Ilocos Norte, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION AND COMPOSITION. The GAD M & E Team of Laoag City is hereby organized with the following composition:

SECTION 2. ROLES AND RESPONSIBILITIES. GAD M & E Team of Laoag City shall have the following duties and functions:

- a) Strengthen the M & E System for gender-responsive programs and projects;
- b) Evaluate the outcomes of the LGU GAD policies, programs and projects and submit GAD Evaluation Report to the DILG Regional Office at the end of the LCE's three-year term; and
- c) Perform such other functions as maybe prescribed by law, local ordinances and authorities.

SECTION 3. CONTINUITY. In the event of transfer, retirement, resignation or separation of the person named herein, the successor shall automatically become the member to represent the office or division.

SECTION 4. REPEALING CLAUSE. All executive orders, rules, regulations and other issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified accordingly.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and in full force and effect.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately upon approval.
