**BIDS AND AWARDS COMMITTEE RESOLUTION DECLARING LOWEST
CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING APPROVAL**

**Resolution INFRA No. 02-016
Series of 2024**

WHEREAS, the City Government of Laoag through its Bids and Awards Committee (BAC), published an Invitation to Bid on January 26 to February 21, 2024 for the Improvement of Multi-Purpose Hall Roofing at Brgy. 46 Nalbo, Laoag City with a total Approved Budget for the Contract (ABC) of **Four Hundred Ninety Nine Thousand Nine Hundred Eighty Pesos One Centavos (P499,980.01)** under Purchase Request (PR) No. CEO-10-082-S dated October 24, 2023;

WHEREAS, in response to the said advertisement, two (2) bidders submitted its bid on February 21, 2024, and during the opening of bids on February 21, 2024 the two (2) bidders passed the preliminary examination of the technical and financial components of its bid;

WHEREAS, the financial bid of two (2) bidders was lower than the ABC, as read and shown below:

WHEREAS, the Report on Detailed Bid Evaluation dated February 21, 2024 submitted by the Technical Working Group (TWG) on the same day, showed that the bid of the two (2) bidders responsive with a Calculated Bid as follows:

WHEREAS, after the deliberation by the BAC on the Report on Detailed Bid Evaluation of the TWG, the bid of LGT2 CONSTRUCTION was declared as the Lowest Calculated and Responsive Bidder;

WHEREAS, the bid of LGT2 CONSTRUCTION underwent post-qualification by the TWG wherein the Post Qualification Report submitted to the BAC on February 23, 2024 disclosed that the bid was responsive in all the requirements specified in the Bidding Documents;

WHEREAS, the Post Qualification Report of the TWG was deliberated upon by the BAC on February 23, 2024, after which LGT2 CONSTRUCTION was declared as the Lowest Calculated and Responsive Bidder;

WHEREAS, Section 36 of the 2016 Revised IRR of Republic Act No. 9184 provides that a Lowest Calculated and Responsive Bid shall be considered for award if it falls under any of the following circumstances:




NOW THEREFORE, the Bids and Awards Committee **RESOLVES** as it does hereby **RESOLVE**;




